Subject: Pradhan Mantri Kisan SAMman Nidhi (PM-KISAN) Scheme – Transfer of benefits -  
regarding

Sir,

The Government with a view to augment the income of the Small and Marginal Farmers has approved a Central Sector Scheme, namely, “**Pradhan Mantri Kisan SAMman Nidhi (PM-KISAN)**” in the current financial year. It has been decided to launch the scheme by the Hon’ble Prime Minister on the 24<sup>th</sup> February, 2019 followed by transfer of benefits to farmers directly to their bank account on the same day. The transfer of benefits would be executed through NPCI. In this regard, the following points may kindly be ensured:


1. The credit should flow into beneficiary’s account on the 24<sup>th</sup> February, 2019. 24<sup>th</sup> February, 2019 being Sunday, NPCI may carry out settlement either on the 22<sup>nd</sup> or on the 25<sup>th</sup>, as may be feasible, and arrange to release the transactions to the banks on the 24<sup>th</sup> morning for credit to the beneficiaries.
2. The scheme has already been registered with DBT with DBT Code ARPR2 and the work of agency registration on PFMS is going on, which will be completed by the 19<sup>th</sup> February, 2019.
3. PFMS will be advised to get the Aadhar and account number details validated through PFMS platform before submission of FTOs (Fund Transfer Orders) to PFMS platform for onward transmission of payment files to the sponsor banks of the state on similar lines as done by the MGNREGA Programme.
4. We shall arrange to provide complete transactional data and funds to the sponsor banks well in advance to enable them to commence uploading the files into NPCI system from the 22<sup>nd</sup> February, 2019 morning.
